Programme Aim: The purpose of this award is to equip the learner with the knowledge, skills, and competence to carry out horticultural duties and tasks safely. On completion of this programme learners should be able to understand the safety hazards associated with the use of a range of the horticultural equipment, demonstrating PPE requirements for a range of tasks. Learners will be capable of correct recording of hazards and risks, while implementing appropriate procedures needed to prevent damage to the environment. Learners will operate a range of tools and equipment correctly including lawn mowers, strimmer's, hedge trimmers, tractors, and pruning equipment.

Participants of this programme will:

- Explore and develop understanding of hazards and risks associated with using horticulture tools
- · Identify and use PPE correctly
- Demonstrate the correct techniques for manual lifting and carrying
- Interpret and comply with hazards and instructions for use on pesticide labels
- Use lawn mowers, strimmer's, hedge trimmers, tractors, and pruning equipment
- Prevent damage to the environment while undertaking horticultural tasks including waste disposal
- Record accidents in the workplace correctly

Duration	This programme will run for 4 contact days depending on the project and will require participants to complete some work in their own time
Who should attend this course	People seeking skills in, or are looking to gain formal qualification in Horticulture
Required fluency in generic skills	Learners entering programmes leading to awards at level 4 will usually be comfortable reading, drafting, preparing and understanding personally relevant information, including quantitative information. Learners will also be capable of solving familiar problems well, independently and as part of a group
QQI Assessment	Participants who wish to achieve a QQI Component Certificate must complete 80% Skills Demonstration and 20% Examination
Resources Required in Order to Successfully Complete the Module	Some personal learning / study time will be required from participants. Programme packs, Assessment Briefs and some equipment will be provided as a part of the programme
Specific Entry/Access & Exemptions required	A learner seeking entry to a programme leading to awards at level 4 does not need a previous formal qualification. Some learners may have achieved some certification at level 3 and we would recommend they have life or work experience within the chosen programme sector. Recognition of Prior Learning may be considered to gain access without having certification entry requirements, to gain exception within a programme, attain an award based on experience which they don't hold formal qualification in, contact our office for more information
